

## **INITIAL REGISTRATION AND LICENSURE**

If you answer yes to any of the following questions, please provide an explanation in the space provided below or on a separate piece of paper. Based on your response, the College may ask you for additional details or supporting documentation. Answering yes to any of the below questions does not in itself disqualify you from registration/licensure.

### **Employment**

1. Have you ever been terminated from employment for reasons related to your conduct, character, incapacity, or incompetence?

“Incapacity” refers to a medical, physical, mental, or emotional condition or disorder that renders you incompetent, or has rendered you incompetent in the past, or that endangers or may have endangered the health or safety of patients/clients.

“Incompetence” refers to the display of lack of knowledge, skill or judgement in your practice of paramedicine that, having regard to all the circumstances, rendered it unsafe for you to practise at the time or renders you unsafe to continue in practice now without remedial assistance.

### **Academic**

2. Have you ever been subject to any complaints or findings in any academic programs you have participated in that raise issues of academic integrity or suitability to engage in the practice of any regulated profession?
3. Have you ever been dismissed, expelled, or removed from any educational institutions or programs in which you have been enrolled?

### **Licensing, Complaints and Discipline**

4. Are you currently registered or licensed to practice with any regulated profession in or outside of Canada?
5. Have you ever been subject to any complaints, investigative and/or disciplinary processes by a registration/licensing authority in any jurisdiction?

(This includes any process where you were the subject of a complaint respecting the practice of your profession, or any process resulting in the suspension of your license or registration, the imposition of conditions or restrictions, consensual reprimands, informal agreements to restrict or refrain from practice, consensual revocations, and undertakings or settlement agreements entered into before, during the course of, or as a result of an investigation or disciplinary proceeding).

6. Are you currently the subject of any complaint, investigation, or other proceeding by any registration/licensing authority in any jurisdiction?
7. Have you ever been denied a permit, licence, or registration by any occupational or professional authority in any jurisdiction?

### Legal Proceedings

8. Have you ever been involved in a civil proceeding, legal action, insurance or other claim that was in any way related to your practice of any regulated profession or your professional activities?
9. Have you ever been sued in a civil proceeding related to negligence, or for any other matter or incident that relates to your ability to undertake the practice of any regulated profession?
10. Have you ever agreed to a settlement as a means to resolve any civil proceeding respecting your professional conduct, competence, character, capacity, or fitness to practice?
11. Has a judgement ever been rendered against you pertaining to your practice of any regulated profession?

### Criminal and Other Offences

12. **You are reminded that under the *Paramedics Act*, you are required to immediately report to the College any criminal charges or charges under the *Controlled Drugs and Substances Act*.**

(For purposes of this question, an “offence includes a criminal offence, an offence under the *Controlled Drugs and Substances Act*, or an offence arising from the operation of a motor vehicle (other than a speeding ticket), for which you have not been pardoned or for which you have not received a Record Suspension.)

Have you ever been charged with, pled guilty to, or found guilty of an offence, either inside or outside of Canada?

13. Have you ever been charged with or pled guilty to a criminal offence that resulted in you entering into a diversion program, mental health court, or any other resolution process including a conditional or curative discharge, as an alternative to conviction or prosecution?

### Capacity

14. Have you been harmfully involved with drugs or alcohol or received treatment relating to your use of drugs or alcohol?
15. Have you been hospitalized, advised to be in hospital, or otherwise voluntarily or involuntarily admitted into an institution for any psychiatric condition or disorder?
16. Based upon your personal history, current circumstances, and any professional opinion or advice you have received, are you currently experiencing any condition or ailment that is reasonably likely to substantially impair your ability to safely perform the duties required in the practice of paramedicine?

### General

17. Is there to your knowledge or belief any event, circumstance, condition, or matter not disclosed in your replies to the preceding questions that touches or may concern your conduct, character,

fitness to practice, capacity and/or reputation and that you know or believe might be considered an impediment to your registration?
